The 2015 CHET Dream Big! Competition is a drawing and essay competition that encourages Connecticut students in grades K-8 to think about how college may help them achieve their dreams and make a difference in the world. It also serves to remind parents of the importance of saving for college early through a CHET direct-sold 529 college savings account. The program is sponsored by the Connecticut State Treasurer's Office, TIAA-CREF Tuition Financing, Inc. and CHET.

#### Grades K-3

- An original drawing illustrating, "What do I want to do after I go to college?"

#### Grades 4-8

- An original essay answering the question, "How will I change the world after I go to college?"

## PRIZES

- **Statewide Grand Prizes:** Four \$1,000 CHET account contributions
- **County Prizes:** 80 \$500 CHET account contributions
- **NEW School Prizes:** Eight schools will win a \$500 prize check

## HOW TO ENTER

- The 2015 Dream Big! Competition is open to all Connecticut K-8 students.

- Entries must be received by: **March 31, 2015.**
- Winners will be notified no later than **May 15, 2015.**
